**Post Session**

Proofs from your session will be delivered digitally via an online password protect gallery to client 3 days after session. Selected photos will have white balance, exposure/contrast, color vibrancy and saturation adjusted. In addition selected photos will be sharpen, cropped and finalized for delivery.

**Photo Delivery**

Photographer will select photos for delivery to client. Selected and edited digital photo delivered electronically 14 days after session. All digital photos will be delivered to client via Pix Oasis and USB drive will be mailed. Pix Oasis is a professional digital photo delivery platform and is used similar to Dropbox, but does not require a password or approval to view the delivered photos. Also, the link from the uploaded photos can be easily shared with anyone that has email. Pix Oasis is far more user friendly than Dropbox, for both the photographer and client.

**Additional Fees and Information**

ALL above fees are for LOCATION sessions. There are an additional fees for STUDIO sessions which is \$40 per hour weekdays and \$55 per hour weeknights and weekends. Additional fees for studio session are based on 1 hour set-up time and length of session.

Travel fees may apply for locations outside of the 25 mile service areas from San Mateo Ca. or for multiple shoot locations

Unedited photos are not included and are not available for purchase

Selected images delivered in both color and black & white

- Additional digital photos ordered from the sessions are \$50 each, which includes basic retouching. Basic retouching does not include contouring for slimming effect, removable of items from photo or hair retouching, Special editing(Photoshop) addition fee. .

All prints sizes available. Please inquire regarding prices. Prints delivered 3 weeks after selections.

Photographs are property of Carmichael Images and may be used in portfolios and/or as part of promotional products. If you do not wish to have your photos included in the photographer's portfolio, you may purchase the rights to the images for an additional price of \$100 per photo.

**Booking Information:**

For all sessions a \$150 non-fundable session retainer is required to book and hold the date for your session and serves as a cancellation fee. However, the fee can be credited towards a future session. The remaining balance is due before the session date.

**PAYMENT:**

All retainer fees can be paid via cash, money order, PayPal or Zelle.



**CANCELLATION POLICY:**

Any client who does not cancel or reschedule within 48 hours of session will forfeit the \$150 retainer and it will serve as a cancellation fee. Retainer fee can be credited towards a future session if the client reschedules the appointment by calling 48 hours prior to the date of session and re-booking at an agreeable date and time.

If Carmichael Images cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness or emergency, then the Photographer shall return the retainer fee to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera or other media malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event Carmichael Images fails to perform for any other reason, Carmichael Images shall not be liable for any amount in excess of all monies paid.
